

Scandinavian Enviro Systems secures bridge financing of MSEK 7,5

Scandinavian Enviro Systems AB (publ) ("Enviro" or "the Company") has, with the help of the biggest shareholder, secured the need for financing for the coming 4 months.

Enviro secures its financing covering the need for working capital until the end of May 2018. This financing solution has been conducted by direct financing from the biggest shareholder of the Company, Pegroco Holding AB.

The total financing amount is SEK 7,5 million and will be in power up to May 31, 2018. The cost for the financing corresponds to a yearly interest of 12%. The main part of the previously communicated bridge financing will be prolonged for the same period and at the same conditions.

"We are one of the bigger shareholders in Enviro and we believe in the leading technology, which the Company has developed for end of life tyres." says Thomas Brue, CEO of Pegroco Invest AB

"We are very happy that our biggest shareholder shows their trust in our technology by supporting us with this financing." says Thomas Sörensson, CEO of Enviro.

Enviro is currently also exploring a long-term financing plan and will revert with more detailed information within a short period of time.
